Vendors will receive a designed space for the day. Vendors bring their own canopy, table, chairs and trashcan. **All food vendors must obtain a Valid City Business License and with the required permits/approval from the Department of Health (765-6606).** No electricity available. Only quiet generators will be allowed. All vendors must follow the Downtown Street Fair rules and regulations. Vendors are responsible for their own items and sales. Please bring a trash container for your booth and carry out your own trash – boxes, leftover food, etc.

**Set up starts at 8:30 am, fairgoers begin to arrive around 10:00 – the official event start this year.** Please keep your booth open until 8 pm.

To sign up, fill out this form & enclose payment. A confirmation letter will be emailed. Locations assigned in the order that payment & registration forms are received. **Vendors must sign liability waiver** (below).
