Vendors will receive a 10X10 space for the day (if a larger space is required please contact office, it will affect location and fee). Vendors are to bring their own canopies, tables, chairs and trash bags. Please bring a trash box & take away your own trash! We do not have access to electricity or water. Washrooms are located in the Gateway Mall, our office, and the Museum.**

We require and expect all vendors to keep their booths open until the end of the event. To apply, please fill out this form & enclose payment. Confirmation will be emailed so be sure to give your email address. Placement will be assigned in the order that payment & registration forms are received. Registration fee is non-refundable. **Vendors must read and sign the liability waiver.** Food Vendors please use the food vendor application!
